The administration is placed in the hands of the township board, comprised of the supervisor, clerk, treasurer and two trustees which you elect to office.</p> <p style="text-align: center;">TOWNSHIP BOARD MEETINGS</p> <p>The regular monthly meetings are held the third Monday of each month. Meetings start at 7:00 p.m. Come and participate in your township’s business. You may appeal your assessment to the BOR at the March meeting(s).
