

Notice of Public Hearing

Notice is hereby given that the Zoning Board of Appeals of Jonesfield Township, Saginaw County, Michigan, will hold a public hearing on Thursday, October 29, 2020, at 6:00 p.m., to consider DTE Energy's request for 55variance requests for 24 WTG towers.

Section 612(l) of the Jonesfield Township Zoning Ordinance requires each WTG tower to be setback from all adjacent property lines and road right-of-way lines a minimum distance equal to the height of the tower, including the top of blade in its vertical position. DTE's variance application requests approval of certain property lines setbacks less than a distance equal to the height of the tower, including the top of the blade in its vertical position. This public hearing is being held as part of a public meeting of the Jonesfield Township Zoning Board of Appeals as provided in this Notice.

This hearing will be held at the Jonesfield Township Hall at 217 N. Eddy Street, Merrill, MI 48637. The Township will be practicing safe distancing and other reasonable measures to mitigate the spread of COVID-19. The following properties in Jonesfield Township are the subject of this request:
