RESOLUTION TO ESTABLISH JONESFIELD TOWNSHIP OFFICERS SALARY

This resolution is used when NO ANNUAL MEETING is held.

A separate resolution must be adopted for each office (Attorney General Opinion 6422).

WHEREAS, according to MCL 41.95(3), in a township that does not hold an annual meeting, the salary for officers composing the township board shall be determined by the township board, and

WHEREAS, the Jonesfield Township Board deems that an adjustment in the salary of the office of Clerk is warranted, and

WHEREAS, at the March, 2017 board meeting, the then current \$14,000.00 Clerk salary was increased by 2% to a new salary of \$14,280.00, and

WHEREAS, at the October, 2017 board meeting it was decided to outsource township payroll to Viking Tax at a cost of \$100.00 per month or \$1,200.00 annually; the payroll responsibility previously being that of the township Clerk, and

WHEREAS, at the Special Meeting of the board on January 29, 2018, it was decided to accept the resignation of Julie Foye, the current Clerk effective February 1, 2018 and to appoint Marcia Stanley as the new Clerk to serve until an elected Clerk comes into office after the November, 2018 mid-term election, and

WHEREAS, it is Julie Foye's desire to appoint Tracey Slodowski as new Deputy Clerk effectively immediately, and

WHEREAS, it is the desire of the board to delegate the duties of elections to Julie Foye's newly appointed Deputy Clerk, Tracey Slodowski effective February 1, 2018 and to compensate the new Deputy Clerk \$2,000.00 to do all those tasks necessary and directed by the new Clerk to ensure a successful mid-term election, and

WHEREAS, it is acknowledged that the Jonesfield Township Clerk's salary will likely need to be adjusted after the mid-term election, now

THEREFORE, BE IT RESOLVED, that as of February 1, 2018, the salary of the office of Clerk shall be (\$14,280.00 less \$1,200 annually less \$2,000.00) as follows:
