- b. Roundtable for the good of the township – Clerk Stanley mentioned the need for the consideration of raising costs of building/electrical/mechanical permits for the township. Auditor brought it to the attention of the clerk that we are coming up short in the building department when including the monthly wage for the Building Inspector.
